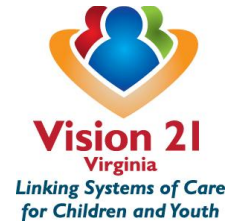

## ***Pilot Site Selection***

The ad hoc Pilot Site Selection Committee's work is to analyze and recruit the four sites where the screening tool, training and training manual will be piloted during the first phase of implementation. This month, we held three webinars to introduce potential Pilot Sites to our project. The introduction included background information about the project, inclusion criteria, and what each locality will receive for participating in the six month Pilot process. We are seeking four localities to participate in the Pilot with at least three systems involved. All Pilot Sites will receive training from project staff and national partners, technical assistance, and concise data that specifically correlates to their population. Currently, we have two localities selected.

## ***Training***

The Training Committee's primary focus is to review and analyze curricula and training methods for existing screening tools that include content on victimization. Work is now underway to develop an outline for the training manual. This includes identifying the content of the manual based on perceived needs as they relate to making sure that those administering the screening tool understand its purpose, maintain maximum fidelity while using the tool in order to collect accurate and pertinent information on possible victimization, and complete the process with little or no added trauma to the person being screened.

## ***Screening Tools***

The Screening Tools Committee is tasked with researching and reviewing current screening tools and response protocols to assess their relevancy in relation to the project. Committee members have been working with project staff and technical assistance providers from the National Council of Juvenile and Family Court Judges (NCJFCJ) and the National Child Traumatic Stress Network (NCTSN) to review the current tool and develop a scoring criterion. The Committee and project staff is well aware that the screening tool, formally named the Virginia Victimization Screen, and accompanying training content will evolve and develop as we receive feedback from the Partner Agency Team and Pilot Sites.

## ***Organization & Policy Analysis***

The Organization and Policy Analysis Committee focuses on state-level understanding of practices and policies that influence the identification and treatment of child and youth victims. The Organization and Policy Analysis Committee has concluded its work in developing and evaluating data for the Commonwealth of Virginia Organizational Assessment, which was administered to the central office staff who support programs and services for children, youth, and transitioning young adults. The committee will transition to analyzing policies, guidance, and standards provided by state agencies. Policies and code sections to be analyzed will be identified and prioritized after a review of findings from all of the data collected to explore overall themes from all deliverables during the planning phase.
